

REGULATIONS OF THE "AIR FAIR STATUETTE" COMPETITION

§ 1

1. These Regulations constitute a legal basis for the proceedings of the Competition.

1. The Organizer of the Competition is Wojskowe Zakłady Lotnicze No. 2 S.A. with its registered office at 107 Szubińska Street, 85-915 Bydgoszcz, e-mail: biuro@airfair.pl, hereinafter referred to as the "Competition Organizer".

§ 3

- 1. Applications to the Competition may include the following:
- 2. Innovative solutions within the scope of the product exhibited on fair stands;
- 3. Innovative designs in the test or pre-implementation analysis stage, which frameworks are presented on fair stands;
- 4. Innovative research studies presented on fair stands;
- 5. Complex exhibition offers.
- 2. Competition application must contain the following:
- a. Degree of innovative solutions utilization;
- b. Product/design and its utilization economical value (price, cost);
- c. Product/design/study/complex exhibition offer functionality;
- d. Product/complex exhibition offer esthetics.

§4

- 1. The awards in the Competition are the following:
 - "AIR FAIR STATUETTE" 1st Category,
 - ➤ "AIR FAIR STATUETTE" 2nd Category,
 - ➤ AIR FAIR Honorable Mention.
- 2. The number of awards granted is determined by the Competition Jury.
- 3. The awards foreseen in the competition are granted for a specific, properly made application.
- 4. Awards granting and handing-in will take place at the official announcement, of the Competition results on the first day of the Fair.

- The Competition Organizer will advice the awarded applicants about the decision, as well as of the place and time of award handing-in, one clock hour prior to the official Competition results announcement.
- 6. Competition winners are entitled to use the fact of award winning for their promotional activities.

§5

- 7. Conditions for application acceptance:
 - a. Application of a product/design/study/complex exhibition offer on a form constituting Attachment No. 1 to these Regulations - to the AIR FAIR Office in the Wojskowe Zakłady Lotnicze No. 2 S.A. area on the first day of the Fair, up to 1 hour after the official Fair opening.
 - b. Applications shall be made in sealed envelopes described "Konkurs AIR FAIR".

§6

- 1. Competition participants may be all the participants and exhibitors (co-exhibitors) in the AIR FAIR. The participants may apply individually or make up teams.
- 2. Solutions notified by WZL No. 2 S.A., its employees, and the members of the Competition Jury are excluded from the Competition.
- 3. The products for which application is made should be described with an information on the product being a candidate to the "AIR FAIR STATUETTE" award.
- 4. The Participants applying with a product to the Competition are obliged to make it available to be seen by the Jury for the entire duration of the Fair.
- 5. In the case of being awarded with the "AIR FAIR STATUETTE" or with the Honorable Mention, the Competition laureate is obliged to deliver a product presentation in electronic form within 30 days after the Fair finish in order to prepare informative material promoting the "AIR FAIR STATUETTE" Competition laureates the presentation should contain company address data, logotype, description in Polish and in English, and photos.

- 1. Competition Jury appointed by the Competition Organizer will supervise the course of the Competition.
- 2. A person organizing the Jury works and documenting the Competition Jury works the Jury Secretary will take part in the Jury works.
- 3. The Competition Jury makes decision based on the documents, the product/design/complex exhibition offer, and its own assessment. The Jury's sessions are proceeding in camera, and its decisions are sovereign, final and non-actionable. The Jury takes decisions by a majority of votes.

§ 8

1. Application to the competition is tantamount with acceptance of the conditions set forth in these Regulations.
