Public Event Rules and Regulations

Chapter 1

- 1. These Rules and Regulations (hereinafter referred to as "Rules and Regulations") have been issued pursuant to the provisions of the Act of 20 March 2009 on the public events safety (hereinafter referred to as the "Act") and pursuant to the provisions of the Civil Code.
- 2. Rules and Regulations are issued by the public event organizer (Wojskowe Zakłady Lotnicze Nr 2 S.A in Bydgoszcz, Szubińska 107 Street,), hereinafter referred to as the "Organizer". The public event will take place on a separated area of Wojskowe Zakłady Lotnicze No. 2 S.A. ul. Szubińska 107 in Bydgoszcz.
- 3. Rules and Regulations are addressed to all persons present in the Event Area in the course of its running. Every person present in the Event Area during the Event shall comply with the provisions of these Regulations.
- 4. The aim of these Regulations is to ensure safety of the Event by regulating the rules of behaviour of persons present at the Event and using the venue of the Event as well as devices and equipment located in the Event's Area.
- 5. The terms used in these Regulations are understood as follows:
 - **The Security Services:** persons appointed by the Organizer, including the staff of the security or property protection agency, identified by the identity tags to take care of the security of those who participate in the Event. Members of the Security Services shall wear clearly displayed identity tags that include the name of the drawer, ID number and a photograph, validity date, seal and signature of the drawer;
 - **The Event Area** refers to a separated area, where the Event is organized or any other area where the Event will be relocated due to some important reasons. This information will be provided before the start of the Event;
 - The Participant of the Event shall mean the person who takes part in the Event.

Chapter 2

- 1. The admission to the area of the Event if for free and for all persons interested in the Event.
- 2. At the Area of the event it is forbidden to bring and possess the following:
 - weapon or other dangerous objects,
 - explosives,
 - pyrotechnics,
 - flammable materials,
 - alcoholic beverages,
 - narcotic or psychotropic drugs.
- 3. It is forbidden to bring dogs and other animals to the Event Area and conduct any trading activity or any profit-making activity in the Event Area without the authorization of the Organizers.
- 4. The Organizer of the Event can refuse the admission to the Event to persons:
 - under the visible influence of alcohol, narcotics, psychotropic substances and the like;
 - bearing weapon or other dangerous objects, materials, products, beverages, narcotic drugs or substances;
 - behaving aggressively or provocatively or in any other way posing a threat to the safety and order of the Event.

- 5. Whoever brings or possesses a weapon at the Event or other dangerous objects, explosives, pyrotechnic materials or fire-risk materials is subjected to arrest or restriction of liberty.
- 6. Event Participants and all other persons present in the Event Area are obliged to follow the Security's instructions, including the instructions of the Security Manager. The refusal to comply with these instructions may only result from these being in contradiction with the generally applicable provisions of the law.
- 7. Minors up to 13 years of age attending the Event are under the sole responsibility of the person who exercises custody thereof.

Chapter 3

- 1. The Organizer ensures the security of persons present at the Event and the order in the course of the Event by, among others:
 - the security and information services properly uniformed and holding identity tags;
 - appointing the Security Manager being in charge of the security and the management of their work;
 - providing medical assistance, and sanitary and hygiene facilities;
 - relocating the Event Area to another place in case of such a necessity.
- 2. Within the scope specified by the Act and executive provisions, the Organizer is authorized to record the Event, in particular, the persons' conduct by means of audio and video recording equipment.
- 3. The Organizer shall record the course of the Event for the purpose of documentation, promotion and advertising of the Event and future events, the Organizer and sponsors. The image of persons present in the Event Area may be recorded and then popularized for the purpose of documentation, reporting, advertising and promotional actions.
- 4. The Organizer specifies the division of the Event Area as zones where Security Services provide permanent protection:
 - technical and social facilities,
 - the auditorium and standing area for the audience,
 - main entrance areas,
 - emergency exits from the area.
- 5. The Organizer provides fire protection by assuring that:
 - the staff, the Security Services and the Organizer are acquainted with the location of the hand-operated fire-fighting equipment and hydrants, and with the procedure in the case of fire:

The Security Services shall be acquainted with the procedures in the event of fire or any other local hazard in time and place of the public event organized on the premises of Wojskowe Zakłady Lotnicze No. 2 S.A., ul. Szubińska 107 in Bydgoszcz and trained on evacuation procedures, methods of alarming the fire brigade, the rules of using the hand-operated fire-fighting equipment and the rules of the first medical assistance.

- 6. The Organizer reserves the right to specify and introduce changes to the programme of the Event due to justified reasons, moreover, the Organizer reserves the right to specify and introduce changes to the programme regarding artistic performances and the duration of the Event without any prior consultation and compensation.
- 7. The Organizer reserves the right to cancel the Event without prior notification and shall not be obliged to compensate for this.

Chapter 4

- 1. Under the provisions of the Act, the Security Services are entitled to:
- check the Participants' authorization to stay at the Event Area;
- check the identity of the Participants;
- check the contents of the baggage, the persons' clothing in case of suspicion that these persons bring in or possess dangerous objects;
- instruct the persons disturbing the public order or acting against the Rules and Regulations of the public event to obey the Rules and Regulations of the public event, and in case of not following the security instructions such persons will be asked to leave the Event's Area;
- use physical force in the form of restraining locks and similar techniques in the event of danger threatening goods being under the security services protection or in case of the attack on the member of the security services or any other person pursuant to the Art. 38 of the Act on the security of people and property of 22 August 1997 (Journals of Laws No. 114, item 740, as amended),
- apprehend persons posing direct threat to other people's life and health and to the protected property in order to hand such persons over immediately to the police.

Chapter 5

1. Issues not regulated herein shall be subject to the provisions of the Act and the Civil Code.

The Rules and Regulations will be available to the Participants of the Event in the form of a B1 poster.
